What information do we collect about you?

Specific Collection of Personal Identifiable Information

Enquiry Form / Contact Form/ Request Form

Consultation/Record Form

These forms are a contractual obligation deeming that you have provided and supplied the correct personal and medical information required to be able to be treated/receive our products and services at the clinic. We advise that it is a requirement to retain patient and client consultation records for up to seven years following the last occasion on which treatment or service was given containing personal information. The retaining of data is necessary where required for contractual, legal or regulatory purposes.

Purchases

In processing your order, we may send your details to leasing companies/agencies as per your request to purchase the product which may also require using information from credit reference agencies and fraud prevention agencies.

Delivery & Invoice Address Forms

The delivery & invoice address form is part of the process required for any purchased products from Bristol Aesthetics Clinics Ltd T/A Flawless Medispa. The information collected allows us to fulfil your order by delivering and invoicing goods to the specified address at time of purchase. We advise that we are legally required to store contact details for tax purposes with the data being held securely by us on companies that have purchased products and services from us for the required time by HMRC. Credit / Debit Card Payments

User Session	PHPSESSID	This cookie is used to identify you as a user between page loads. It is an essential part of the content management and shopping cart systems on our website. Unless you register and log-in, you will simply be assigned an anonymous user session. This cookie is destroyed each time you close your browser.
Cookie Usage Notice	CookieNotice	This cookie is used to record if you have read and accepted the notice regarding the use of cookies on our website. If set, this cookie remains active for 100 days and prevents the notice from being displayed again.
Shopping Cart	BASKET REGION DISCOUNT_CODE DELIVERY INVOICE	These cookies are an essential part of the shopping cart system on our website. The BASKET cookie records the items you have placed in your basket as you navigate from page to page. The REGION cookie records your geographical region for the purpose of calculating delivery costs. The DISCOUNT_CODE cookie records a discount code that you may have entered, so that discounts can be applied to your shopping cart. The DELIVERY and INVOICE cookies record your address selections as you navigate the checkout process. All of these cookies may persist between sessions to enable you to resume your shopping at a later date.
